Ukrainian SSR Assails U.S. Blackmail And Threats Against UN Member States

(An Interview with Gennadi Oudovenko, Permanent Representative of the Ukrainian SSR to the United Nations, in connection with the Reagan Administration's demand to reduce the staff of the Permanent Missions of the Ukrainian SSR, the USSR and the Byelorussian SSR to the United Nations.)

Question: Readers of The Ukrainian News are aware of the demand by the U.S. Administration for a substantial reduction in the staff of the Permanent Missions of three founding members of the United Nations, including the Ukrainian SSR. What measures has Ukraine taken in response to that demand? Does the latter comply with the provisions of international agreements?

Answer: The Ukrainian SSR Permanent Mission sent a note to the U.S. Mission lodging a vigorous protest against the illegal demand of the U.S. Administration. Secondly, the note was brought to the attention of United Nations Secretary-General Javier Perez de Cuellar when I met him personally. The note was also circulated among UN Members as an official UN document.

I expressed our view in my statement made at the meeting

of the Committee on Relations with the Host Country. It should be noted that the illegal action of the United States - the host country of the UN Headquarters - has caused legitimate concern in United Nations circles.

Our note rejects as totally fabricated and groundless the assertions of the U.S. Government as to the nature of our activities at the UN. That arbitrary and unfounded action is a flagrant violation by the U.S. of the obligation it voluntarily undertook, as the host country of the UN Headquarters, to ensure the necessary conditions for normal functioning of the United Nations and the unhampered participation of UN Member States in the work of the Organization.

Nothing in any existing international agreements, including the UN Headquarters Agreement concluded in 1947 between the UN and the U.S. Administration gives the latter the right to impose numerical limits on the staff of the Permanent Missions of the UN Member States. These missions, as is known, are accredited not to the U.S. Government but to the United Nations. The UN Legal Counsel and the International Law Commission as well as many UN Members, including some Western countries, expressed similar views.

Ukrainians Demand Punishment For War Criminal Hiding In United States

Ten years ago, the New York Times wrote that 10.000 nazi war criminals had found refuge in the United States, a member of the anti-Hitler coalition. One of these war criminals is Sergei Kovalchuk and he has been living at 224 66th Avenue in Philadelphia, Pennsylvania for more than a decade.

Today you can hardly guess that the quiet, thoughtful man had been Deputy Chief of Police in the nazi-occupied town of Lubomil in Western Ukraine of the USSR where the enemy had brutally slaughtered thousands of Soviet civilians in October 1942.

Kathleen Coleman, attorney of the U.S. Justice Department's Office of Special Investigations who visited Lubomil

recently, said that it was a horrible crime of gigantic proportions.

The residents of the little town and neighboring villages gathered at the Lubomil Community Center recently to demand justice on behalf of the innocent victims. People listened with bated breath to eyewitness accounts of what happened that terrible day when Kovalchuk and his cutthroats exterminated the entire popu lation of the Lubomil ghetto.

Ivan Lysenko, the Minister of the local church said: "To this day I hear the heartrending screams of the women and children who were driven to their death by Kovalchuk. With all the power of my soul I demand punishment for the criminal Kovalchuk, that demon and traitor

1986 — The United Nations International Year Of Peace

The United Nations has declared 1986 the International Year of Peace.

Its stated goals for the year are:

1. To stimulate concerted and effective action by the United Nations and its constituent parts in promoting peace, international security and cooperation on the basis of the Charter and in resolving conflicts by peaceful means;

2. To strengthen the United Nations, and 3. To focus attention and encourage reflections on the basic requirements of peace in the contemporary world.

Throughout the world, 1986 will become a focus for intensified efforts to establish a lasting and just peace for all peoples.

The Summit Meeting in Geneva in 1985 gave new hope to the entire human race.

The Geneva meeting also showed that the peace movement must continue its campaign for the abolishment of nuclear missiles as well as an intensified campaign against Star Wars which stands in the path of progress towards disarmament and peaceful co-existence.

Proposals made at Geneva by the Soviet Union exposed the Reagan Star Wars program as being militarily indefensible.

The more recent proposal by the Soviet Union to dismantle all weapons of war by the year 2000 and its continued moratorium on the testing of nuclear weapons also makes conditions even better than ever for united actions of the peace movement, and increase the prospects for 1986 truly becoming an International Year of Peace.


We urge all peace minded people in the Ukrainian-American community to advance the peace issues in whatever organization they are participants.

'Dulles Had Lied To Us. Communism Was Not The Threat We Were Fighting'

It is nighttime and we are encamped in a remote area along the border. A ragtag group of rebels is resting in anticipation of battle. They laugh at what they pian to do to the SOBs after they take over. They are driven by the prospect of power and wealth, not ideology. They are unaware that the president of the United States has described their mission as "preventing the establishment of a Communist beachhead in the Western Hemisphere." They are a tough bunch who scorn negotiation.

The scene is Honduras. But the year is 1954, and the president is Dwight D. Eisenhower, and the rebels are Guatemalan, not Nicaraguan.

As a CIA case officer, I trained Guatemalan exiles in Honduras to invade their own country and unseat the elected president, Jacobo Arbenz. Our liaison officer with the Honduran military was Nestor Sanchez, who is now an assistant secretary of defense and a key policymaker in the current war against Nicaragua.

We worked in secrecy, but rumors of our activities prompted the Organization of American States to dispatch a delegation to Honduras to investigate. Warned by a cable from our Miami head-quarters, we quickly dismantled our base and fled to Nicaragua. It was there that I received the news: Arbenz was out.

I now consider my involvement in the overthrow of Arbenz a terrible mistake, one that this administration seems bent on re-enacting in Nicaragua.

In March, 1954, three months before we toppled Arbenz and installed our handpicked liberator, CIA Director Allen Dulles convened his Guatemalan operatives for a pep talk. Puffing on his pipe, Dulles told us exactly what Ronald Reagan is telling the American people now: that U.S. support for the rebels will foil the spread of communism.

Later I learned that Dulles had lied to us. Communism was not the threat we were fighting at all; land reform was. Fulfilling his campaign pledge to transform Guatemala into a "modern capitalist state," President Arbenz had taken over some unused land belonging to the United Fruit Co. That angered the Boston-based company, which considered its rights to Guatemala superior to those of Guatemalans. So it asked the CIA to overthrow Arbenz, and we complied, trumping up the same charge of spreading subversion that the president now levels at Nicaragua.

True, the Sandinista government has played host

to some pretty unsavory characters and has received arms from the eastern bloc. That must be reckoned with. But in his determination to replace Nicaraguan President Daniel Ortega with someone more malleable to U.S. influence, Reagan has greatly exaggerated the Sandinistas' ability to subvert its neighbors. The greatest threat to stability in Central America is the United States' unwillingness to heed the call for negotiations made by other Latin American nations.

The CIA's meddling in Guatemala led to 31 years of repressive military rule and the deaths of more than 100,000 Guatemalans; some of the exiles I trained are alleged to be among the perpetrators. Furthermore, the overthrow of the Arbenz government destroyed vital social and economic reforms, including land redistribution, mandatory universal social security and trade-union rights.

Support for the Nicaraguan contras portends the same bloodshed. Even if the contras are able to unseat the Sandinista government, can anyone sincerely believe that they will be able to govern? Hundreds of thousands of Nicaraguans have been beneficiaries of land, health care and education reforms under the current government; they are hardly likely to acquiesce to rule imposed by the United States.

On a recent trip to northern Nicaragua, I toured the countryside and talked with Nicaraguans from all walks of life. Contra attacks and atrocities have only stiffened their resolve to prevail over what they regard as foreign intervention. But, surprisingly, these Nicaraguans also said that they liked Americans, though not our government. We should not ignore this residue of good will, which will surely not remain if we continue on our present course.

Congress and the American people must decide whether this country will embark on a new era of conciliation with its southern neighbors or revert to an earlier era of underhanded coercion. Eisenhower's Arbenz must not become Reagan's Ortega.

I am 70 years old now. I have lived and worked in Latin America for more than 30 years. Done with skullduggery, I devote my time to painting some of the region's beautiful scenery. It is painful to see my government repeat the same mistake. I have grown up. I only wish my government would as well.

(Editor's Note: For the last few months the American news media and Ukrainian nationalist organizations and newspapers in the United States have been noisily stirring up anti-Soviet hatred in connection with the attempt by American officials to persuade Ukrainian seaman Myroslav Medvid to defect. The nationalists allege Medvid was abused by Soviet authorities and forcibly returned to his homeland. This article appeared in the newspaper Molod Ukrainy [Youth of Ukraine] which has a nationwide circulation in the Soviet Union.)

On January 31, just on the day when the Voice of America had already several times announced that "Myroslav Medvid is not among the living any more," I was sitting in the house of his parents in the village of Siltsi, Lviv Region. I did not have to express my condolences to them, though, for Myroslav was sitting together with us, alive and joyful.

Although there was a time when Myroslav's life was in danger, it did not take place here at home, but in America. This happened on the Mississippi River when the Soviet ship Marshal Konev was anchored in the harbor of New Orleans.

In the evening of the same day the ship dropped its anchor, Myroslav Medvid went down the deck and noticed that one of the lights over the ladder was not bright enough. To find the reason, he leaned over the rail to look. All of a sudden he felt dizzy, lost his balance and fell overboard from a height of nearly 45 feet.

The American port service should be duly complimented the crew of a patrol boat acted efficiently and in full conformity with seamen's traditions: not to leave a man in trouble. The unconscious Myroslav Medvid was returned to his ship.

The ship doctor Olexander Osypchuk spent the whole night by Myroslav's bedside. The result of his fall was a left arm fracture and other serious injuries. His blood pressure fluctuated for the two days Myroslav was unconscious.

Meanwhile, people who introduced themselves as representatives of the local authorities illegally boarded the ship. Among them was an official from the U.S. State Department who introduced himself as Louis Sell. He demanded to see Medvid and insisted that he be sent to shore to a Red Cross hospital, although all necessary aid was

given to the patient by a competent ship doctor.

When Myroslav came to two days later, the Americans put forward new demands: despite the captain's protest, they insisted that the talks about the destiny of the Soviet sailor be conducted outside the ship.

A Mexican ship anchored nearby was chosen as neutral territory for the negotiations. Accompanied by the doctor, the Soviet captain and a representative of the Soviet Embassy in Washington, Myroslav got on the land on which I was born and on American boat.

Suddenly the boat changed direction and headed for an American Coast Guard ship, not the Mexican vessel. For six hours the Americans were brainwashing Medvid. They wanted from him at least a hint that his fall was not an accident, but an attempt to defect to the United States. All they heard from Myroslav was: "I have my homeland — the Soviet Union — and I had no intention to leave the

which my parents live."

When the Americans saw that psychological pressure on Myroslav had not worked, they changed their tactics. They said they would continue talking to him on shore, in private. Myroslav protested categorically as the Americans appointed a psychiatrist to look after him. The doctor brought a trunkful of specialized equipment to use on Myroslav but he flatly refused.

Yalta


When we arrived at Simferopol airport, two young girls met us. They were students in their last year majoring in English. They had a local map to give us some idea of where we were. They wanted the experience of speaking English with someone. Then we had a two-and-a -half hour bus ride to Yalta. The scenery would have been beautiful if we could have seen it all, but it rained the whole way. The hotel was the largest one we were in so far, and the nicest. We had a balcony outside our room. From the balcony I could see a beautiful park, the Black Sea, mountains, and part of the city.

The next morning the sun was out for about 15 minutes, then it poured for the rest of our visit. Their roads are narrow and winding, up and down. We went to the palace where the Yalta Agreement was signed between Roosevelt, Churchill, and Stalin. They named a street after Franklin Roosevelt. That is giving him real honor. All of their streets are named after their heroes. The palace itself left me in awe of its grandeur. Since we were a small group, we were privileged to go upstairs to see art treasures that "the people" had made in different regions of the USSR. The Soviet Union has 15 republics, and over 120 nationalities and languages.

... We visited another hotel and saw our first and only real luxury during the trip. It cost. 90 rubles a day for a suite of rooms. The suite had two balconies overlooking the Black Sea, plush velvet sofa and chairs, color TV, spa, sauna, an indoor pool, and elegant dining. That's where to go for a vacation and stay for 2 weeks.

The town borders the waterfront, big stores and all. Here they also have a walking area along the waterfront, complete

with many flowers.

After dinner we saw a variety show modern Ukrainian. It was really good, a Las Vegas type of show but smaller. We had front row seats. After the show there was dancing with a live orchestra.

All the way through the trip, Gene's boa scarf created quite a stir. It created a lot of attention from passersby and started a lot of conversations.

We left Yalta for Moscow. We stayed at the same hotel in Moscow, but had much nicer rooms. Again we got in late and left at noon the next day. 

Studies show that garlic may Yields: 3 to 4 servings. have distinctive health benefits including protective value in preventing heart disease, stroke, cancer and diabetes, as well as antibiotic properties. The Egyptians, as far back as 1550, suggested that garlic-based remedies be used for ailments from body weakness and headache to tumors of the throat. The Romans used garlic for such ailments as hoarseness and hemmorrhoids, epilepsy and tuberculosis, as a laxative and as a diuretic. The Greek physician Galen called it the common folk's "heal-all."

Even botanists plant garlic amongst their flowers because it seems to guarantee riddance from aphids, leaf beetles, cutworms and other such common insects.

How do you know which is an herb and which is a spice?

An herb is either a plant or that part of a plant that does not develop woody tissue. Dried herbs have a more potent flavor.


