Your Civil Rights, as these pages show, are under attack.

We believe that this attack grows out of the current war hysteria, and out of the desire of big business to divide the

American people in the face of a developing depression. We believe that jimcrow and segregation have become policies of government—that the legislative, judicial, and executive arms of the government today are brazenly used to maintain the oppression of the Negro people. We believe that the "thought-control" heresy trial at Foley Square is an attempt to drive the country down the road to Fascism.

Large numbers of Americans are rightfully alarmed. The Council on Christian and Social Progress of the Northern Baptist Convention, the Federal Council of the Churches of Christ in America, the Quakers, and other religious bodies have expressed their concern through publications and statements.

Trade unions, fraternal and civic groups have expressed their awareness of the danger to the Bill of Rights.

CRC shares their concern and urges that its own policy of resolute action in defense of civil and human rights be supported and duplicated everywhere.

The CRC is a fighting organization that puts its faith in the people!
