## Human Wrongs in El Salvador

Ten thousand people died participating in the "political process" in El Salvador last year--victims of the almost unbelievable repression practiced daily by the ruling military junta.

The new Administration in Washington has turned its back on this continuing slaughter, and is using its own convenient definition of human rights to justify its lack of concern about the murders, torture, rape and terror being committed by that country's government. It is only slightly surprising, then, that the Reagan Administration shows a similar lack of interest in the fact that six Americans, who were working with the impoverished people of that country, have also been murdered by the Salvadorean government.

At a well-attended MfS general meeting held Feb. 10, this was made painfully clear by Herman Montoya, a Salvadoran



who is here to speak to Americans about the situation in his homeland. Debbie Levinson of the Committee in Solidarity with the People of Guatemala also spoke at the meeting, and a powerful 45-minute Dutch-produced film on El Salvador, Revolution or Death, was presented.

#### Living Conditions

While the 20th century has brought medical advances, educational opportunities and everyday conveniences to much of the world, the people of Central America have continued to live in abject poverty. Millions of them lack adequate food, clothing and shelter, and have no education or health facilities, and no voice in their government. In these countries, 2-3% of the population own as much as 70% of the land, and to varying degees in each of them, U.S. corporate interests have played an important role in helping to maintain the status quo.

Labor is cheap in Central America; workers are paid pennies an hour, and attempts at union organizing are met with brutality we rarely see in this part of the world. Revolution or Death included scenes from a recent job action at a plantation in El Salvador. The workers, who were demanding higher wages from their (ex-Nazi) employer, were summarily shot down by the military police. Some of the dead strikers had been young children.

#### Kidnappings, Torture Commonplace

But these events are fairly commonplace in El Salvador, Herman Montoya reported. "I grew up there, and I've seen (Continued on P. 6)

PEACE AND PALESTINE: A DIFFERENT VIEW

To the N.Y. Mobilizer:

Within progressive circles in the United States and elsewhere it is very much in vogue to equate Zionism with racism, condemn the Camp David Peace Initiative, and give blind support to the Palestine Liberation Organization. In the January/February Mobilizer, Mark Lurinsky's "Peace and Palestine: A Personal View" discarded the Camp David accords as just another imperialist plot, and insinuated that while Israel had little or no respect for human rights, the P.L.O. was not a terrorist organization.

Zionism is the national liberation movement of the Jewish people. To speak rationally and justly about the Arab-Israeli conflict one must keep in mind that Israel is the Jewish homeland, as one must also remember that the Palestinians need a homeland. If one looks back to the years immediately preceding the establishment of the state of Israel, one sees that the Zionists accepted many proposals put forth by the United Nations for Jewish-Arab land distribution in the area (all of which provided the Jews with much less land than was in their hands following the 1948 War of Independence), but the Arabs accepted none of these proposals. They would not accept a Jewish state. Shortly after the British left Palestine in 1948 the armies of Lebanon, Syria, Iraq, Jordan, Saudi Arabia, Egypt, and Algeria invaded the newly established ate of Israel. Since then, three wars voked by Egypt, Syria, Lebanon, and n in 1956, 1967, and 1973, and numerous terrorist attacks on civilians, have killed thousands. After the wars in 1956 and 1967, Israel signed peace treaties with these countries and returned the land captured from them during the war, only to be invaded a few years later from the very land they had returned.

Terrorism has been perpetrated against Israeli civilians through hijackings of airplanes and buses, terrorist attacks and killings in apartment houses (Naharia and Kiryat Shmona), and murders of children at school (Ma'alot). Recently, during the invasion of Kibbutz Misgav Am (a communal farm), terrorists took over a children's house and murdered the children. Israelis have seen their children thrown out of sixth story windows by these terrorists. During the 1972 Summer Olympics in Munich Israeli athletes were murdered in the Olympics compound simply because they were Israelis. Israelis do not pick up even a piece of paper in the streets of their cities for fear it might be a bomb. The list is endless. It is no wonder to me that these people, this nation, are wary of their Arab neighbors and the P.L.O.

#### Camp David Accords Praised

The Camp David accords are important not because of what they themselves say, but rather because there is now hope that the years of war will be over in the Middle East. It is the first time that an Arab country has recognized Israel's right to exist, something which the P.L.O. has never done. It is not a solution, but the beginning of a long process that will hopefully bring about cooperation and respect from all parties in the region.

While living in Israel for the last two years I was active in Shalom Achshav (Peace Now), the Israeli peace movement. · Shalom Achshav opposes many of the policies of the government of the state of Israel, but is still Zionist. It opposes annexation and settlement of the occupied territories (Sinai, the West Bank, the Golan Heights, and the Gaza Strip), and ranking members of Shalom Achshav have met with officials of the P.L.O. in search of better understanding of the Palestinian situation and opportunities for cooperation and compromise. Shalom Achshav is growing and with its help hopefully a solution will come about.

# NUCLEAR INDUSTRY STRATEGY UNFOLDS ON LONG ISLAND

The Long Island Lighting Company (LILCO) in conjunction with more than two dozen other utilities from around the country met in early 1980 at a seminar held in Miami Beach designed to develop a strategy to deal with antimiclear protestors. On Long Island the strategy is beginning to unfold as an organized campaign of harassment, intimidation and legal entanglement.

#### THE HISTORY

In September 1980, just ten days before the "Citizens' Strike" against LILCO, the utility was granted an order to "show cause" asking for a permanent injunction banning gatherings at the Shoreham plant. LILCO asked that the order include all those who "aided and abetted" or "planned" for past and future civil-disobedience actions and used language implying violence in SHAD's past actions. All civil-disobedience events planned by SHAD have required non-violence training as a condition for participation and have been carried out in a non-violent and peaceful manner.

Summonses were indiscriminately served on dozens of Long Island, New York City and Westchester County people including some who had attended only one meeting, in an attempt to involve them in a \$2million lawsuit for damages. LILCO has claimed that at previous demonstrations organized by the SHAD Alliance, it had incurred losses exceeding \$2million. These damages have not been clearly defined, and no damage to the plant or to any person has ever occurred because of the peaceful and non-violent demonstrations.

#### THE CLIMATE OF HARASSMENT SPREADS

At this time, even though the demonstrations are past history, LILCO has continued in its pursuit of a broad permanent injunction. They have continued to harass and intimidate opponents of nuclear power and by so doing are posing a threat to all those who wish to exercise their First Amendment rights by expressing unpopular or controversial opinions. LILCO's chilling tactics are an attempt to stop all local opposition to the plant and to the company's unsafe, uneconomic and undemocratic corporate policies.

In preparation for the hearings on the injunction, six defendants have been subpoenaed by LILCO and have been subjected to long (up to 7 hours) deposition sessions. It is clear that LILCO is attempting to use this litigation to learn, without justification, the identities of any and all persons and organizations which have or might actively oppose LILCO's nuclear programs. In the course of the depositions LILCO has demanded (without success to date) that the defendants identify individuals who have expressed concerns about the Shoreham plant, or who have attended meetings, where the meetings were held, who took minutes-in general a demand to name-names. Defendants have been questioned about their personal finances, files and records. A printer's records have been subpoenaed and organizational bank records sought. The Suffolk County police records of arrests at Shoreham for the past three years above been subpoensed. The defendants have taken a strong position that under no circumstances will the names of people who have attended rallies, or who have supported the opposition to Shoreham by attending meetings or contributing funds ever be revealed.

Because the defendants have not answered these questions LILCO is going to court in an attempt to compel answers despite the First Amendment.

It is clear that these proceedings are threats to the basic American rights to demonstrate, express opinions which may be controversial and to petition for change and could have far-ranging affects.

#### "Guard Against the Impostures of Pretended Patriotism"

On September 26, 1979, the New York Times ran an important article entitled: "Vietnam Veterans Found to Have Major Problems." I think that this article, by Bernard Weinraub, is especially important, not only because Weinraub reported on the first federally sponsored study of Vietnam veterans (conducted by the New York-based Center for Policy Research), but because of a choice excerpt quoted from that study: "What many Vietnam veterans are saying, some loudly and others more softly, is that they suffer from a lack of participation" in their society. "Since Vietnam, no call to action has pierced their cynicism; nobody has applied the historic salve that could heal their wounded sense of collective pride." It seems to me, speaking as one of 2.4 million veterans who served in Vietnam, that it is true that Vietnam vets as a class of individuals do "suffer from a lack of participation" in American life and that, as a result, the country suffers.

#### 'Call to Action'

I would like to see Vietnam vets receive a "call to action" from their fellow citizens (the majority of whom also suffer from a lack of participation in our society), a patriotic appeal that would urgently request that they serve their country again. And I would like to see them answer that call. However, the patriotism that Vietnam vets should display today is most emphatically not the sort of "patriotism" called for by the director of the Selective Service System in his January 4, 1980, letter to the House Armed Services Committee, stressing that registration for the draft should provide "reinforcement and recognition by the general public, particularly among the young segment of the population, of their obligation and privilege to serve the nation." This kind of "patriotism" is not the sort that will heal the nation of what ails it. It is an aspect of the disease with which we are afflicted, and it only serves to make things worse, here and ab-

Registration, the draft, and the various wars that the Pentagon is preparing to wage are in no way in the interest of the people of the United States. In gen-

eral, official policy, both foreign and domestic, is not in the national interest; it is in the interest only of corporate business, and it does not increase, it reduces, our security as a nation. The people of this nation should redefine for themselves their national security in terms of the national, rather than the corporate-business, interest. National security is attainable only through peace, and peace is possible only if the people of the U.S. themselves see to it. American youth should not be led--or rather, misled--to the slaughter in new Vietnams or even worse conflicts, and all for the sake of the well-off minority. Instead, the youth of this country should be working for the peaceful and constructive use of America's vast resources and great productive power throughout the world; for disarmament through a practical program; and for a domestic policy that can provide jobs, health care, housing, and education for all. And Vietnam vets should be with them, in the front ranks, leading them-and learning from them -- in this fight.

#### 'Patriotic Duty' vs. Opulence

In my opinion, the people who run the U.S. don't give a damn about the country, and for years they have been running it into the ground. Yet the new administration has already begun to preach to us, the people, about our patriotic duty. While the average Vietnam vet earns about \$7,000 per year--if he is lucky enough to

have a job--and just might have a family to support, at the ball following the inauguration ceremony, the new First Lady accompanied her husband in a \$10,000 gown, a \$500 pair of shoes, and a \$1,600 alligator handbag. (The alligator--unlike the bald eagle, our national symbol -- is presently off the offical Endangered Species list, but has again become the prey of commercial interests. The bald eagle remains on the list, and is on the verge of extinction.) President Reagan, meanwhile, told the assembled elite, who had paid up to \$500 a ticket to hear his speech, that what the country needs is people "who will sacrifice for it." (Guardian, Jan. 28, 1981)

#### 'War Fever'

The people who are running this country are trying to build up the kind of patriotic fervor that will do us no good; they are trying to whip up a "war fever" to make us forget our real problems, which are at home, and not in Iran, Afghanistan, or Poland, or in El Salvador, South Korea, Thailand, the Philippines, South Africa, (Let us have an open, fair, and full national debate and discussion of these questions, instead of just the government's side of the story presented by the corporate media!) Against the backdrop of a tremendous and accelerating militarization of the economy by the government, and a mew and terrible strategic nuclear firststrike policy that may well get everybody killed, the real needs of our people continue to go unmet.

Our politicians and our generals have mot given up on their intentions to use U'.S. military might to impose the will of tlhe American business establishment upon other countries, no matter what the people of those countries -- and the working people and youth of this country-think about it. Democratic and Republican politicians, who have supported registration, have claimed that registration does not me an there will be a draft. ("I'm not adwocating a draft. We have no intention or need for implementing the draft," said Jimmy Carter when he was president.) But this transparent attempt to deceive the American people only shows that tens of millions of us are against the government's war moves. And the widespread failure to sign up, on the part of patriotic voutth, along with other forms of resistance to the draft, show the same thing.

The Vietnam veteran has a special role to play today in the affairs of the nation. His experience in the armed forces, in the war, and in our society since Vietnam, uniquely qualify him to serve his country again: this time—as George Washington advised in his Farewell Address to the People of the United States, in September, 1796—by guarding his fellow citizens "against the impostures of

the things that happened in the movie many times." Since the government suspects all young people of being sympathetic to the revolution, thousands of them have been arrested, tortured and murdered for the "crime" of being young; children are kidnapped; peaceful demonstrators are shot down in the streets. The victims are peasants, city laborers, students, teachers, lawyers, clergy . . . in short, people from every walk of life. It is this treatment by Central American dictators that has brought the people throughout the region to the point of revolution.

Two years ago, a successful revolution was waged in nearby Nicaragua. The repressive government of General Somoza was brought down, and today, a popular coalition of leftist and religious forces governs that country.

#### U.S.-backed "Coalition"

That revolution has served as an inspiration for struggling people in Central America, and the threat to America's corporate interests has not gone unnoticed by Washington and the Pentagon. As a result, the government in El Salvador was recently replaced (with American approval and assistance) by a so-called coalition of the military and (certain) democratic groups. The U.S. hoped that such a "coalition" would stem the tide of revolutionary activity, and quell even more radical demands. But it soon became clear to the people of El Salvador that the new government in no way represented a compromise, and that it had no intention of improving the quality of their lives. Several of the coalition's civilian leaders resigned and joined the Revolutionary Democratic Front, a genuine coalition made up of Marxists, social democrats, and progressive Christian democrats.

#### Guatemala Situation

As mentioned earlier, the revolutionary activity in Central America is not limited to El Salvador. There is also a war going on in Guatemala. Debbie Levinson pointed out that approximately 40 people are killed every day in that country. The Indians (or Natural People, as they call themselves) who are descendants of the Mayans, are forced to migrate six or seven months out of the year for employment. They work on coffee or cotton

plantations, most of which are U.S.-owned, and they are paid about \$2.00 a day. The crops they harvest are sprayed with DDT, long banned in this country. Here also there is a dearth of hospitals, schools and other social necessities.

Both Levinson and Montoya spoke about the ever-increasing propaganda from the White House and the Pentagon, preparing the American people for intervention in Central America. There are already American advisers in El Salvador, a situation reminiscent of the era just preceding the Vietnam war, and according to some reports, there are also regular U.S. military personnel participating in certain operations. The State Dept. has prepared films on the "communist threat" in Central America, and is showing them to high-school classes across the country. It's little wonder that registration for the draft has not ended under Reagan.



#### U.S. Tax \$\$\$ in El Salvador

As Mr. Montoya said, "Your tax dollars go to El Salvador to kill Salvadoreans, while here you have no heat in your homes. Schools have to be closed for lack of money. There's a freeze on federal job hiring. And now President Reagan says you must tighten your belts." (All except for the military, of course, which continues to grow fatter and richer.)

"We are not against the American people," he continued. "We know that many sections of your country are also oppressed. We hate death. We love life. We want a better lefe than what we've had. There is nothing in between. Ours is a revolution of love."

Dear Friends,

In a series of meetings these past months, discussions focused upon activities New York Mobilization for Survival will develop this year. Also discussed were some of the organizational problems which hamper our work. In October, our annual planning conference set the organizing of neighborhood groups (such as Park Slope and the Bronx) as one objective for this year. Two of the issues MFS will focus on in the coming months are the resumption of high-level radioactive-waste shipments through New York City and the ongoing Selective Service registration and probable draft.

In discussions of organizational problems, the following points were raised:

- 1) "The Revolving Door Syndrome": Many people have shown interest in MFS' work, have come to meetings, volunteered in the office, but have not remained active. Have these people felt unwelcome? Have they been excluded from decision-making roles? How can people already active in MFS help new people expand their activities? These were some of the critical questions raised.
- 2) NY MFS has a dual character. On the one hand, it is a coalition of organizations. At the same time, some people active in MFS' work participate as individuals, not representatives of an organization. Unaffiliated individuals have been under-represented on the Steering and Coordinating Committees.
- 3) The NY office maintains a mailing list of close to 8,000 names. Mailings to this entire list are very expensive and time-consuming. We need to know those people who consider themselves an active part of MFS and want to participate in decision-making and/or activities, and those who only want to be kept informed of major developments.

Taking these points into account, the following plans have been made:

- 1) A special mailing list will be developed, comprised of the people who want to receive all Mobilization mailings, announcements of activities, etc. Please be certain to complete and return the enclosed coupon this week.
- 2) Schedules will be arranged for volunteers to work regularly in the office. If you are interested in working at the West 4th St. office, or in your area with other nearby MFS people, please contact Tom De Luca or Nora Lumley at 673-1808.

- 3) Unaffiliated individuals and representatives of organizations and neighborhood MFS groups will be recognized as members of NY MFS. People not affiliated with another member organization or a neighborhood MFS can become members at large by indicating their agreement with the MFS' goals on the coupon.
- 4) Representatives of organizations, neighborhood MFS', and members-atlarge will serve on the new Executive Committee. (Please let us know if you are interested in the nomination and election of representatives. We will then contact you once nominations open.

Difficult times are ahead. Politically, we feel it is most important that MFS be able to provide a strong public voice and resistance to the promised military build-up by the Reagan administration as well as the other reactionary policies which will be forthcoming. People who have been sympathetic towards MFS' work in the past now need to come forward again.

#### Seeing Through the Electronic Smog

The anti-nuclear movement has begun to raise public consciousness about the dangers of ionizing radiation, such as that which comes from X-rays and gamma rays. There is much less public understanding of the menace of "electronic smog": the pollution of workplaces and the atmosphere by non-ionizing radiation, in particular, by microwaves and radiofrequency (RF) waves.

New Yorker staff writer Paul Brodeur pointed out in The Zapping of America:
Microwaves, Their Deadly Risk and the
Cover-up (New York: W.W. Norton, 1977)
that this lack of knowledge results from the military's efforts to block research into health and genetic damage caused by non-ionizing radiation. This cover-up has begun to fall apart in the last few years.

There is an urgent need for lay people and movement-oriented scientists to educate themselves and others about the problem and how to eliminate it. A few examples here illustrate the need for urgency.

White House Report

• In 1971, a White House report indicated the magnitude of the problem of microwave and radiofrequency exposure:

'The electromagnetic radiations emanating from radar, television, communications systems, microwave ovens, industrial heat-treatment systems, medical diathermy units, and other sources permeate the modern environment, both civilian and military....This type of man-made radiation exposure has no counterpart in man's evolutionary background; it was relatively negligible prior to World War II.... Power levels in and around American cities, airports, military installations ...industry and homes may already be biologically significant....The population at risk is not really known; it may be special groups; it may well be the entire population....The consequences of undervaluing or misjudging the biological effects of long-term, low-level exposure could become a critical problem, especially if genetic effects are involved. " (See Brodeur, p.14.)

• In 1977, a National Institute of Occupational Safety and Health (NIOSH) report noted that "more than 70% of the industrial sources surveyed exceeded

applicable personnel RF exposure standards." (DHEW (NIOSH) Publication 77-181, p.486)

#### USSR 'Incident'

- The U.S. safety standard is 10 milliwatts per sq. centimeter. Yet, when the Russians beamed microwaves at the U.S. Embassy in Moscow, the maximum levels were either 18 microwatts per sq. centimeter (1/1500 of the U.S. standard) or 4 milliwatts per sq. centimeter (2/5 of the standard), depending on which figures one accepts. In either case, an international incident was sparked by levels that the U.S. government was proclaiming at home to be perfectly safe.
- There are signs of greater public consciousness of the dangers of non-ion-izing radiation. In 1977, NIOSH discovered radiation levels of 1 mw/cm² at the N.Y. Times building. It noted them briefly DHEW (NIOSH) Pub. 78-129, and never pursued the matter. In 1980, emissions of one-fifth that level from TV transmitters at the World Trade Center became front-page news. 1980 also saw the first N.Y. Workers Compensation ruling that microwave exposure had killed a worker, through "brain changes, tissue destruction, and acceleration of arteriosclerosis." (Daily News, 7/4/80)

#### Don't Sit Too Close to the TV

VDTs—the TV—like terminals used in word—processing and other computer—related fields. It has been charged (and denied by the industry) that they can cause radiation—induced cataracts. The Cold Type Organizing Committee recently published a pamphlet, which I helped write. Entitled Don't Sit Too Close to the TV, it summarizes much of the research on CRTs and contains an extensive bibliography. It is available from MfS for \$1 (\$1.50 by mail; bulk rates available).

The need now is for much more information, much wider distribution, and action based on that information.

Did Con Ed do anything to prevent a massive flooding of the reactor building? Con Ed operators even ignored their own flood alarms -- for two weeks -- and four pumps broke. A 120-day outage had been planned for refueling and maintenance; now it looks like the outage will have lasted 226 days if the plant restarts June 1. Indian Point is shut today because it automatically "tripped" itself off after the accident. The NRC has ordered Con Ed not to start it up again until investigations and necessary repairs are completed.

7 \*\*False: What we're paying now doesn't include the "hidden" costs of nuclear energy. Who will pay for dismantling Indian Point when it goes out of service in about 30 years? No knows how much that'll cost—it's r been done. Who pays for the (port and storage of nuclear le? Who pays for the increased t of cancer due to radiation psure? Hint: not Con Ed.

3\*\* False: See #1 about who caused the accident which caused the outage.
Whether the accident endangered the public or damaged the reactor is still under NRC investigation. Former NRC inspector Robert Pollard, now with the Union of Concerned Scientists, contends that the accident seriously threatened public safety, Con Ed is trying to rewrite the past and predict the future.

4\*\*False: Alternative forms of producing electricity—solar or wind power, for example—would be cheaper than oil and nuclear fuel and would employ more people. Nuclear energy is no bargain after you add in the "hidden costs (see #7). (This information is from the Council on Economic Priorities study on jobs and energy.)

8\*\*And everyone wants <u>more</u> nuclear power plants, right? Wrong: A majority of New Yorkers polled by <u>The Daily News</u> last November said they wanted to live without more nukes.

#### Taking the Con Out of Con!

You may have asked yourself why your electric bills should go up while the Indian Point 2 nuslear plant is down. Why, in other word, should you pay for what some prople claim were our mistakes?

The fact is that Indian Point 2 is out of send on the point of send of our mistakes. It is out of service because it needs new pipes in its heat exchangers, a refueling, maintenance work,

and certain plant modifications

which had been planned some time ago.

With benefit of hindsight, some mistakes were made in connection with last month's water-leak incident at Indian Point. We will learn from these mistakes. But they did not cause the present outage or endanger our employees withe public, or damage the reactor.

Even so, you may ask, why should my bills be higher?

The reason is that when Indian Point 2 is not generating we must replace its output largely with oil-generated electricity. Oil is much more expensive than nuclear fuel, about ten times more expensive. 4

#### Why Should You Pay?

But why should you be required to pay the extra cost of oil?

Fuel is the basic raw material from which we produce electricity. It is also the single largest item in our cost of doing business, about one-third of the total cost.

We bill the cost of fuel to our customers in accordance with New York Public Service Commission (PSC) regulations known as the "fuel adjustment factor." Each month, by PSC rules, we charge Con Edison customers for the actual cost of the fuel we used the previous month to generate electricity. In any given month, if the cost of fuel goes up, the fuel charge itemized on your bill also goes up. If the cost goes down, the fuel charge on your bill goes

damage. 9 Indian Point 2 has been taken out of service for two primary reasons. First, to replace all 6.009 pipes in the heat exchangers of the plant's air cooling system. Leaks in some of these pipes, combined with sump pump failures, caused the water accumulation. Sec. ond, to do refueling, modification, and maintenance work which originally had been scheduled to begin in mid-December and run through mid-April.

Prior to the flooding, we had planned to replace leak-prone pipes in one part of the air cooling system. As a result of the increased frequency of water leaks, and tests we performed in October, we decided it would be prudent to replace all the pipes in the entire system before restarting the plan.

#### An Industry-wide Problem

No one can seriously contend that it was Con Edison's fault that the cooler pipes developed water leaks. Leaking cooling systems are an industry-wide problem—not only in nuclear plants, but also in oil-fired and coal-fired plants. 12

The refueling and maintenance procedures have now begun. They are expected to last until early June, possibly longer, possibly somewhat shorter. We will do our best to bring the plant back as rapidly as prudence will permit. 13

When Indian Point 2 is back in service, you will once again reap the benefits of this most economical source of power on the entire Con Edison system. 14

(This message paid for by the stockholders of Con Edison.) 15

6\*\*False: The fuel adjustment surcharge guarantees Con Ed's profits and frees the company from the constraints of free market competition.

5 \*\*Con Ed has no economic incentive to save on fuel costs: it can buy the most expensive oil, for example, as much as it needs, and just pass the cost on to us. Customers of any other business might go to a cheaper company if they didn't like its prices but Con Ed customers have only Con Ed. We're Con Ed's hostages; we can't buy electricity somewhere else. And it's up to us to prove that Con Ed's rates are unfair. The company is presumed innocent, while we're penalized with higher electric costs. But the accident wasn't our fault.

13\*\*...And when the NRC is satisfied that the reactor vessel is still intact and as sturdy as the day it was made by Westinghouse—the same company that builds those flawless cooling systems for nuclear power plants. "You can be sure if it's Westinghouse."

15\*\*Out of the kindness of their hearts, as a civic duty, the generous stockholders sacrificed thousands of dollars of their dividends to send us this message and advertise it in New York's three daily newspapers. Don't they have anything else to do with their money? Are they worried we might get the wrong idea about the accident? Do they know something we don't?



#### Waste Transport Slowed—Not Stopped

The <u>bad news</u> is that federal Transportation Secretary Neil Goldschmidt did indeed issue a regulation overriding NYC's ban on radioactive waste transport through city streets. On Jan. 13, as one of his last official acts, Goldschmidt signed a Dept. of Transportation order that will permit the federal government to decide the routing for nuclear shipments all over the U.S.

The good news, though, is that Gold-schmidt froze the new regulation for one year; it cannot go into effect until Feb. 1, 1982. The delay is important, because it buys time for Congressional hearings to review DOT's action.

#### Credit to Rep. Ferraro

Credit for this delay goes largely to Congresswoman Geraldine Ferraro (D-Queens), who has been pressing for such hearings for many months. The one-year grace period raises new hope that the DOT rule may in fact be overturned by Congress.

Widespread public opposition to the new regulation was expressed at DOT hearings held all over the country during the past several months. At one of the most impassioned of these sessions, held in lNew York in June, MfS representative (Charlotte Wescott gave eloquent testimony (see July/Aug. 1980 N.Y. Mobilizer). Of the more than 100 people testifying, only one (a Lilco representative) spoke in favor of the DOT proposal. This strong opposition means that we must continue working to retain New York's restriction on shipping radioactive waste through our city streets.

#### CUNY Faculty Senate Says No! to Waste Transport

Opposition to the Dept. of Transportation's plan to allow radioactive waste shipment through city streets continues to be expressed from all sides. In January, The City College Faculty Senate of the City University of New York voted overwheelmingly to endorse a resolution opposing the shipment of radioactive waste or other highly radioactive material through New York City's streets and other densely

populated areas.

"This resolution represents the concerned response of the faculty of City College on an issue that strongly affects the health and safety of the people of New York City and other communities," said Dr. Barbara Bellow Watson, Chair of the Faculty Senate's Executive Committee. The resolution, which was transmitted to Mr. Neil Goldschmidt, Secretary of Transportation, reads as follows:

Mindful of our responsibility to our students, to the community, and to ourselves and other employees of the City College of the City University of New York, we hereby express our opposition to the shipment of radioactive material through our city's streets and other densely populated areas.

Dr. Leonard R. Solon, Director of New York City's Bureau for Radiation Control, Department of Health, called the resolution a "progressive action in behalf of public health." He said he believed it was "the first time a group representing the majority of thoughtful opinion of a distinguished American college or university has so expressed themselves on this vital matter."

#### MfS Forms Feminist Task Force

A new task force to begin work on feminist issues will be formed by the New York Mobilization for Survival, it was agreed at the January 14 general meeting. Its aim will be to relate women's issues to other concerns including peace and energy questions, while at the same time attempting to complement the work of other feminist organizations in the area. Several members of New York MfS attended a recent CARASA (Committee for Abortion Rights and Against Sterilization Abuse) meeting to find out what this particular group is currently working on. The fact that abortion rights have recently come under vituperative right-wing attack will likely make this issue a priority of the feminist task force. #### PLO Seen as Terrorists

Of course I am angered by the expropriation of lands on the West Bank. Of course it angers me that Israel might have detonated an atomic bomb. Of course I am angered over the Israeli airstrikes on Palestinian refugee camps. But I cannot understand the slaying of innocent civilians by the P.L.O. and other terrorist groups. All considered I still wholeheartedly support Israel. I believe that we are lying to ourselves if we do not call the P.L.O. terrorists. THEY ARE TERRORISTS and their actions are horrible and unjustifiable and must be condemned. In Mobilization for Survival we should maintain that violence only begets violence and that violence and killing should not be tolerated in any form by any group of people. We should work for the selfdetermination of the Palestinian people, and for a just, nonviolent solution to the Mideast crisis for the Israelis, the Palestinians, and all other peoples involved.

#### Author Replies:

It is heartening that Shmuel Thaler agrees we should work for the self-determination of the Palestinian people. This and most of all the urgent necessity to stop our government from attempting further militarization of the Mideast was the thrust of my article. One can wish the "Peace Now" organization which he supports, and the other peace forces within Israel, nothing but the greatest success. Still, there are some glaring contradictions in his line of discussion.

#### Israeli Terrorist Acts

Thaler's impassioned denunciation of P.L.O. as a "terrorist" organization actions "must be condemned" finds terpart in his attitude toward

Israel's transgressions. If we want to discuss the question of terrorism seriously, we must explicitly say at the outset that Israel's own history has no shortage of exactly the kinds of incidents he alludes to by way of castigating the P.L.O.: the massacre of 254 unarmed Palestinian men, women, and children at Deir Yassin by Menachem Begin's "Irgun" organization, the planting of bombs in the King David and Semiramis hotels, the killing of 49 civilian residents of the village of Kafr Qasim by Israeli troops, and similar incidents. The number of Palestinian civilian lives wantonly snuffed out by the continuing "reprisal" and "preemptive strike" raids by jet bombers employing anti-personnel weapons (such as the "cluster bomb units" used in the Vietnam War) must not be ignored. In any objective counting these would greatly outnumber the civilian victims of Palestinian fedayeen raids. Is it because this activity is done impersonally from an advanced aircraft streaking past at several thousand feet in 'the air that Thaler finds it somehow less barbaric than the act of a guerilla fighter?

#### U.S. Policy

My point is not to absolve anyone of blame, but rather to warn that branding only one party to the conflict as "terrorist," (which, all apologies to Shmuel Thaler, does come down to a sort of racism), invariably serves the most questionable political purposes. If further proof of this is needed, we have only to consider the way our new Secretary of State, General Haig, recently referred to the national liberation struggles in Namibia and El Salvador, among other places, as "Soviet-backed terrorism" in an ill-concealed attempt to introduce a policy of closer alignment with fascist and reactionary regimes. With regard to the P.L.O., the use of the term "terrorist" by our media and government sources has had no other purpose but to advance the claim that the P.L.O. is outside the pale of those with whom we can negotiate peace. If we truly stand for peace and the right of peoples to self-determination this claim is unacceptable.

#### Washington Implicated

Without going into detail, let me also say that Thaler's reference to the history of warfare between Israel and neighboring Arab states is similarly onesided and mistaken. Both in 1956, as is well known, and in 1967, Israel was in fact directly responsible for initiating the hostilities. More candid official Washington sources and even Zionist sources do not deny this. And concerning the events leading to the outbreak of the 1973 war, the president of the World Jewish Congress, Nahum Goldman, blames Washington for "supporting their /Israeli leaders'/ policy of rejecting any agreement unless all Israel's demands are accepted..." To say that "Zionism is the national liberation movement of the Jewish people," as Thaler does, does not contribute to the cause of peace any more than it changes objective facts.

#### Quotes Zionist Founder

It would seem that the main problem Thaler has with the P.L.O. and other Arab parties is their failure so far to recognize the state of Israel, and in keeping with this he arbitrarily singles out the Arab rejection of the 1948 U.N. plan for partition of Palestine as the point of origin of the whole conflict. But we canmot ignore the pre-1948 history of the area and in particular, the Zionist movement's coercion of the Arab majority of Palestine (as late as 1914 some 88 percent of the population) out of the land, with the assistance of the British colonial authorities. (Lest anyone suspect that this characterization exaggerates, I quote the founder of political Zionism, Theodor Herzl: "We shall try to spirit the penniless population across the border by secwring employment for it in the transit countries while denying it any employment in our own country. Both the process of expropriation and the removal of the poor must be carried out discreetly and circumspectly." (From Complete Diaries)

#### Question for Peace Movement

Arab recognition of Israel is a bridge that can only be crossed in the

context of a general settlement of all outstanding issues including, to restate what should perhaps be obvious, Israel's recognition of the nation of over four million Palestinians, now living under Israel's control in forced exile. Nothing Shmuel Thaler says justifies his optimism that the separate U.S.-sponsored agreement between Israel and Egypt was a step toward such a settlement, particularly when its authors, for the most part, make no bones about their intention to permanently exclude the possibility of selfdetermination for the Palestinians. Particularly now, after the inauguration of Ronald Reagan, the problem of opposing our own government's aggressive role in the region remains the main question for the peace movement of our country.

#### Can You Get Out of Town Fast Enough?

If you live in Westchester, Rockland, Orange or Putnam County, you may have to get out of town fast in the event of a serious accident at Indian Point. But don't worry. The folks at Con Ed and N.Y. State Power Authority (operators of the Indian Point plants) are working on a nifty evacuation plan to help you.

They still have to iron out a few wrinkles, though. One problem—how to transport some 23,000 people who don't happen to have cars in those four counties. The idea is to bring in 100 (!) buses to shuttle them all to safety. But who will drive the buses? Since county government can't require bus drivers to work in a radiation emergency, the Indian Point evacuation planners are counting on volunteer drivers instead. The trouble is, despite requests for such volunteers, no one has stepped forward so far.

#### County Legislators Criticize Plan

County Legislators Criticize Plan

This is but one of the many ludicrous inadequacies in the proposed plan. It has been justifiably criticized by County Executives in all four affected counties. Westchester County Executive Alfred DelBello has been particularly outspoken.

Though the Nuclear Regulartory Commission could approve the plan without



the consent of these county officials, to do so would probably be politically very unwise. The best way to make sure it doesn't happen is to keep the plan out in the open. Between now and April 1 (when the NRC requires that the plants be 'implemented') is an absolutely crucial time. There are several things that you, as a concerned citizen, can do:

Residents of Westchester, Rockland Putnam and Orange Counties

o Insist that copies of the draft version of the plan be made available in your local library, so that the public can read and comment on it to the NRC. Contact your local and state legislators to get this done.

o If the draft plan is not made readily available, write to Donald Davidoff, Manager, Nuclear Emergency Planning Group, to complain. (His address: N.Y. State Plaza, Power Bldg., Albany, N.Y. 12236. A copy should go to John Ahearne, Chairman, U.S. Nuclear Regulatory Commission,

Washington, D.C. 20555.)

Urge Local Hearings
o Request that widely publicized public
hearings be held in your community, before
the April 1 deadline. Contact your county
legislators to get this done. When the
hearings are held, attend them, encourage
your friends to attend, and ask questions.

too, and let the editor know you expect serious coverage of the hearings. Residents of New York City

Although New York City isn't included in the draft plan (because it is outside the somewhat arbitrary 10-mile zone the plan encompasses), it almost certainly would feel the effect of a serious accident at Indian Point. Depending on wind direction, radioactive material could easily hit town, with significant health consequences.

- Therefore, NYC residents should besiege the Mayor's Office of Civil Preparedness with letters and phone calls to complain about the plan's failure to consider New York City. (Address: Inspector Robert Littlejohn, Director, Office of Civil Preparedness, 1 Police Plaza, Room 804, New York City 10038).
- Request that copies of the draft plan be made abailable to members of the public, through libraries, etc. These requests should be made through the Office of Civil

Preparedness (address above).

The plan in its present form contains so many major flaws and inconsistencies as to be a joke. But no one will be laughing if we one day have to rely on it to escape a major accident at Indian Point. Only the bright light of public scrutiny—and vigorous support for those public officials who have so far resisted being hoodwinked by Con Ed et al.—will keep this absurd plan from becoming a reality.
